## **SOLAS APPROVED**

The 'Jason's Cradle' is SOLAS approved as a multi function access, rescue and retrieval device according to its configuration, developed from standard components assembled to suit one or more modes of use which include:

- Casualty recovery in horizontal position from water to survival craft and to ship.
- Stretcher for use in horizontal position.
- Scramble net.



## All users and vessel operators should please consider the following points in order to ensure the best possible performance from their Jason's Cradle.

- 1. The equipment satisfies the objectives required by LSA code, Regulation I/1.2 in matter of strength and suitability for marine environment. However it is to be confirmed that the use of this Life-Saving Appliance is acceptable to the Flag Administration (of the vessel on which the Life-Saving Appliance is installed) on an installation by installation basis.
- 2. For each installation of the equipment the "Company" (Ship Owner/ Vessel Operator) should conduct and document a Risk Assessment that takes into account the anticipated conditions and ship specific characteristics and/or survival craft specific characteristics.
- **3.** Ship's Plan and Procedures for recovery of person from water should take into account the equipment intended to be used and developed in accordance with MSC.1/Circ. 1447 and MSC.1/Circular 1182.
- **4.**On board drills should be conducted to ensure that the crew are familiar with this equipment and Ship's recovery procedures.
- 5. Installation on board: The installation of the equipment is not part of this Design Appraisal or Certificate. All such arrangements are to be to the satisfaction of the vessel's Administration and/or RO acting on their behalf on an installation by installation basis.
